# ITEM 3

**Minutes of Regular Meeting of  
Reclamation District 828  
Held on July 15, 2016**

---

The regular meeting of the Board of Trustees of Reclamation District 828 was held at 8:30 p.m. on July 15, 2016 at 509 West Weber Avenue, 5th Floor, Stockton, California 95203.

**Item No. 1:** Call to Order. The meeting was called to order at 8:31 p.m. Present were President Bill Mendelson and Trustee Robert Merdinger. Trustee Deby Provost was absent. Also present was Dan Schroeder, District Counsel, Andy Pinasco, and Chris Neudeck, District Engineer.

**Item No. 2:** Public Comment. Dominique Gulli commented on recent reports involving the SJAFCA Smith Canal Project.

**Item No. 3:** Approval of Minutes. The minutes of the May 13, 2016 regular meeting were approved unanimously by the Trustees present on a motion by Trustee Robert Merdinger, seconded by President Bill Mendelson.

**Item No. 4:** Financial Report. Mr. Schroeder reported on the financial status of the District.

- a. Adopt Resolution 2016-04 Certifying Assessments To Be Collected And Establishing A Procedure For Collection. Mr. Schroeder reviewed the content and purpose of the Resolution with the Trustees. Mr. Neudeck and Mr. Schroeder recommended that the Trustees continue to levee the full assessment due to the ongoing maintenance tasks and projects for the upcoming years. Mr. Gulli commented that he thought the assessments should be lower during the public hearing. Mr. Schroeder and Mr. Neudeck reminded the Trustees that due to maintenance that had been deferred for years. Resolution 2016-04 was adopted unanimously by the Trustees present on a motion by President Bill Mendelson, seconded by Trustee Robert Merdinger.
- b. Adopt 2016-2017 Budget. Mr. Schroeder introduced the format of the budget in a rough draft format for discussion purposes. The Trustees and staff commented on items that were no longer expenses and suggested categories to be added to the budget format. The item will be revised at the October 2016 Board meeting.
- c. Approve 2015-2016 Fiscal Year Audit Contract. Mr. Schroeder reviewed the proposal from Schwartz, Giannini, Lantsberger & Adamson to perform the audit for the 2015-2016 fiscal years. The proposal was accepted and the President was authorized to sign it unanimously by the Trustees present on a motion by President Bill Mendelson, seconded by Trustee Robert Merdinger.

**Item No. 5:** Engineer's Report. Mr. Neudeck provided the Trustees with a written and oral report.

a. Vegetation Issues. He first reported on the levee subventions program which includes vegetation removal and the process for addressing aggressive vegetation such as bamboo. He explained the program this year will cost less than \$25,000. He then presented the proposal from Custom Spraying Inc. to perform vegetation abatement in the amount \$6,750.00. The proposal was accepted and the President was authorized to sign it unanimously by the Trustees present on a motion by Trustee Robert Merdinger, seconded by President Bill Mendelson.

b. Closure Structure. Mr. Neudeck next reported on the SJAFCA Smith Canal Closure Structure Project and the two lawsuits that have been filed. SJAFCA anticipates they will be doing construction in 2017/2018 time frame. He also report on status of Caltrans on plan for riprap under the highway.

c. He finally reported on the status of the subventions program funding legislation and reauthorization of the program.

**Item No. 6:** Adopt Resolution 2016-05 Revising District Bylaws. Mr. Schroeder reviewed the resolution and bylaws revision to the regular meeting date. Resolution 2016-05 was adopted unanimously by the Trustees present on a motion by Trustee Robert Merdinger, seconded by President Bill Mendelson.

**Item No. 7:** Adopt Resolution 2016-06 Authorizing And Directing Filing Of Notice Of Exemption For Routine Maintenance, For Fiscal Year 2016-2017. Mr. Schroeder and Mr. Neudeck explained the purpose of the resolution and CEQA exemptions and why it is adopted annually. Resolution 2016-06 was adopted unanimously by the Trustees present on a motion by Trustee Robert Merdinger, seconded by President Bill Mendelson.

**Item No. 8:** Adopt Resolution 2016-07 Establishing Policy Regarding The Installation Of Riprap On Private Property. Mr. Schroeder and Mr. Neudeck reported on the program that RD 1614 has implemented. The Trustees asked about the process with willing property owners and those instances where the district determines that work needs to be done and the property owner is opposed to the work. Resolution 2016-07 was adopted unanimously by the Trustees present on a motion by Trustee Robert Merdinger, seconded by President Bill Mendelson.

**Item No. 9:** Correspondence. There were no comments or discussions on the correspondence attached to the agenda packet.

**Item No. 10:** Calendar. Mr. Schroeder reviewed the calendar with the Trustees

**Item No. 11:** Approval of Bills. Mr. Schroeder reported on the outstanding bills that had been received and the status of the District's accounts and ratification of the stipend payment to Trustee Provost for the last regular meeting. The payment of the attached bills was approved unanimously by the Trustees on a motion by a motion by Trustee Robert Merdinger, seconded by President Bill Mendelson.

**Item No. 13:** Adjournment. The meeting was adjourned at 9:20 a.m. unanimously by the Trustees on a motion by Trustee Robert Merdinger, seconded by President Bill Mendelson.

### **Remediation Expenses:**

Expenses incurred for or in connection with the investigation, monitoring, removal, disposal, treatment, or neutralization of pollution conditions to the extent required by: (1) Federal, state or local laws, regulations or statutes, or any subsequent amendments thereof enacted to address pollution conditions; and (2) a legally executed state voluntary program governing the cleanup of "pollution conditions."

### **Outdoor Property:**

Fixed or permanent structures that are outside covered real property including but not limited to:

- ✦ Historical markers or flagpoles;
- ✦ Sirens, antennas, towers, satellite dishes, or similar structures and their associated equipment;
- ✦ Exterior signs not located at a premises;
- ✦ Fences or retaining walls;
- ✦ Storage sheds, garages, pavilions or other similar buildings or structures not located at a premises;
- ✦ Dumpsters, concrete trash containers, or permanent recycling bins;
- ✦ Hydrants; or
- ✦ Electric utility power transmission and distribution lines and related equipment owned by the insured.

### **Equipment Breakdown:**

Direct damage to mechanical, electrical or pressure systems as follows:

- ✦ Mechanical breakdown including rupture or bursting caused by centrifugal force;
- ✦ Artificially generated electrical current, including electrical arcing, that disturbs electrical devices, appliances or wires;
- ✦ Explosion of steam boilers, steam piping, steam engines or steam turbines owned or leased by you, or operated under your control;
- ✦ Loss or damage to steam boilers, steam pipes, steam engines or steam turbines; or
- ✦ Loss or damage to hot water boilers or other water heating equipment;
- ✦ If covered electrical equipment requires drying out as a result of a flood, we will pay for the direct expenses for such drying out.
- ✦ None of the following are covered objects as respects to equipment breakdown:
  - a. Insulating or refractory material;
  - b. Buried vessel or piping;
  - c. Sewer piping, piping forming a part of a fire protection system or water piping other than:
    - (1) Feed water piping between any boiler and its feed pump or injector;
    - (2) Boiler condensate return piping; or
    - (3) Water piping forming a part of refrigerating and air conditioning vessels and piping used for cooling, humidifying or space heating purposes;
  - d. Structure, foundation, cabinet or compartment containing the object;

President William Mendelson of Reclamation District 828, Weber Tract:

I have levee protection/safety issues that I would like addressed regarding the homeless encampment on Shimizu drive, located under the Interstate 5 Bridge which crosses the Smith Canal. This neglected, vacant public property has become a liability to the surrounding neighborhood because it is a garbage dumping grounds and attracts homeless transients, vandals, criminals, parolees, drug users, drug paraphernalia, prostitutes, and smells like feces throughout the day and night. Often, there are controlled fires which I've seen used as primitive heating and cooking methods which creates a fire hazard risk to the bridge and a dangerous safety risk to children. I've often seen cars parked on the levee with smoke coming from vehicles, drinking in cars, and have even heard female screaming which I reported to both local Fire Dept. and Stockton Police, respectively.

My understanding is that The City of Stockton has an ordinance in place "to protect neighborhoods from becoming blighted through the lack of adequate maintenance and security of vacant buildings and properties, S.M.C. section 15.32." As a neighboring property owner in the community, I have been denied full use and enjoyment of my property and have realized retarding appreciation of real property value due to the disruption of neighborhood stability this has caused. This has caused compromised our community's safety and has caused me great financial harm since 2012.

In addition to the aforementioned criminal and health concerns, I have flooding concerns about how this homeless encampment is compromising the integrity and safety of our levees so I am also forwarding this letter to the Central Valley Flood Protection Board and Reclamation District 828, Weber Tract. I have seen instances where they burn vegetation along the side of the levee and there is evidence of holes dug out.

The issues that I have are with the City of Stockton and the local Reclamation District 828 for failing to enforce these codes and ordinances. It seems there have been long-term negligence with enforcement and no apparent future plan to come into compliance. I was shocked to learn that this has been reported already since I can testify with pictures that this has been an ongoing problem since at least 2012.

The public safety concerns of the I5 Bridge will be forwarded to Cal Trans, California Highway Patrol, and San Joaquin County Sheriff's Office.

President William Mendelson, I have already received acknowledgement of the issue. Please describe, in detail, why nothing has been about it, what will be done going forward and when?




