### **RESOLUTION 2019-07**

### RESOLUTION ORDERING BOARD OF TRUSTEES ELECTION BY ALL-MAILED BALLOT ON SELECTED ELECTION DATE AND NOMINATING INDIVIDUALS TO THE ELECTION BOARD

WHEREAS, pursuant to Water Code section 50730, there shall be an election in Reclamation District No. 828 ("District") on the first Tuesday after the first Monday in November in each odd-numbered year; and

WHEREAS, the District's voters adopted the all-mailed ballot procedure for conducting future general District elections at the District's 2015 General District Election; and

WHEREAS, Water Code section 50707 prohibits all-mailed ballot elections to be held on the first Tuesday after the first Monday in November of each year; and

WHEREAS, the District will hold an all-mailed ballot election on Wednesday, November 6, 2019 to fill two seats on the Board of Trustees ("Board") as required by law; and

WHEREAS, the Board desires to maximize the opportunity of landowners to cast their ballots; and

WHEREAS, the election shall be conducted pursuant to Water Code sections 50700 et seq. which provides election procedures for Reclamation Districts; and

WHEREAS, the Board desires to submit nominees for the election board which shall be appointed by the Board of Supervisors of San Joaquin County.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Reclamation District 828 that:

- 1. The foregoing recitals are true and correct.
- 2. In accordance with Water Code section 50707, this Resolution 2019-10 provides that the District will hold an all-mailed ballot election on Wednesday, November 6, 2019 to fill two seats on the Board.
- 3. The Board hereby nominates the following three individuals to the election board provided for by Water Code section 50700:
  - a. Elvia Trujillo, Judge
  - b. Rhonda Olmo, Judge
  - c. Andy Pinasco, Inspector

- 4. The Board hereby authorizes and directs the District Secretary to publish the Notice of Election as required by law.
- 5. The Board hereby authorizes and directs the District Engineer and District Secretary to prepare and certify the assessment roll for the assessment levied in the fiscal year 2018/2019 and provide such roll to the election board.
- 6. The Board hereby authorizes and directs the District Counsel, District Engineer, and District Secretary to prepare such other appropriate notices, ballots, and documents for the purpose of conducting the all-mailed ballot election.
