
### II. PG&E POLE REPLACEMENT ALONG SHIMIZU


We have performed the following research: (our subject area is inside Smith Canal just east of San Juan Avenue and north of APN 133-460-02, Charles Biggs, 1893 W. Walnut St.)

- 1) Reviewed APN Maps and Details Sheets for Smith Canal. Focused on APN 133-470-01, Reclamation District #828.
- 2) Ordered and review the record information: Quitclaim Deeds IN 84006543, 84006544 and IN 85003608 from the City of Stockton to RD 828 for a 2/3 interest, but these deeds just address the area adjacent to RD 828 where I-5 crosses Smith Canal.(approx. 1400' west of I-5 and approx. 1600' east of I-5.
- 3) Pulled Map of Subdivision No 6 of Stockton Acres, Book of Maps, Vol 9, Page 14 for the properties between San Juan Ave and Buena Vista Ave, south of Smith Canal and this map does not have a reference to Smith's Canal title.
- 4) Pulled Grant Deed IN 96005844 for the said Biggs property, APN 133-460-02, and this does not reference Smith's Canal title.

The Assessor Maps would led me to believe that the Reclamation District No 828 has some interest from the centerline of Smith Canal to Smith's Canal's south bank, but the reference documents only cover the area east and west of I-5 as discussed above.

Additional Action – Request additional title documents from a Title Company (vesting documents, preliminary report) for the subject area.
