



### The following was noted:

As requested, I arrived at the district levee area near Shimizu and Wilshire Drive to review a report fire on the levee area. Summarized as follows are my findings and discussions:


- Upon arrival at the area of Shimizu Drive and Wilshire Drive at the levee area, I observed a tree and
  the immediate surrounding area that was subjected to a fire. The tree was scorched, and the
  surrounding immediate area was burned at the ground level area. In addition, the dead-end road
  fencing on the water side hinge point of the roadway was damaged from an apparent vehicular
  accident.
- During my time at the site, a woman in a white Audi Q7 vehicle stopped in front of my company truck. I greeted her, but she displayed a highly agitated demeanor and started with a rant that the district had not been performing tree removal and vegetation maintenance on the levee. She said it was promised that the vegetation work would be completed several months ago and that nothing has been completed. She was very concerned that property owners on the levee will be subjected to dangerous fires. I responded that a lot of the trees are protected and cannot be removed. In addition, I mentioned that a few of the invasive species can be removed She vehemently disagreed with my statements. She then responded by saying that the trees should at least be trimmed up. I agreed with her but mentioned that tree trimming cannot be performed until after the nesting bird season has ended. It was mentioned that there have been numerous fires on the levee areas, and that they appeared to be arson related. I agreed with her that the fires appear to have been deliberately set by someone. It was obvious she was very upset as she simply walked away and took some photos before driving away to review other portions of the district.
- A review of the district levee area revealed that trimming of the handing tree canopy and tree sapling removal services is needed. There is no significant levee vegetation except for a few areas of Arundo that need herbicide spraying.
- I contacted Dave Carr to report my findings and discussions with the disgruntled woman.
- I also contacted Jr. of Dino & Son to collaborate on the timing of the start of vegetation control services on the district levee area.





