### RESOLUTION ESTABLISHING DISTRICT REVOLVING FUND

WHEREAS, Reclamation District No. 828 ("District") intends to open a checking account (hereinafter called "revolving fund") for the purpose primarily of paying payroll for the District employees, and

WHEREAS, the order entitling such fund, pursuant to California Water Code §§50657 and 50658, must be kept in the District's records, and the records of the Treasurer of San Joaquin County;

## NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The Board of Trustees ("Board") of Reclamation District 828, hereby orders the creation of a revolving fund for the District, consisting of a commercial checking account, or additional such accounts, if such additional accounts are ordered from time to time by the Board, and the District hereby assumes responsibility for the disbursement of funds from such fund, and hereby agrees to save and hold the Treasurer of San Joaquin County harmless from any improper disbursement of the fund.
- 2. Checks drawn on such fund shall be signed by at least one member of the Board of Trustees and either the District's legal counsel or District Secretary. The current Trustees are: William Mendelson, Deborah Provost, and Paul Marsh. The current District legal counsel and District Secretary is Daniel J. Schroeder.
